FBI Working on Formal Complaint

NSC went to the FBI (The FBI initially took our case and recorded Prashant on a tapped line demanding \$150,000 from us to stop his actions). NSC was also able to provide the FBI with a confirmed IP address to Prashant's residence in India after he failed to use a proxy server to mask his IP. We were assisted in this by a 3rd party review website where Prashant would frequently troll and post false remarks as if he was a customer of NSC.

Special Cyber Crimes Agent Christopher Cope worked with us for several months while we gave him evidence.

Very very unfortunately the FBI dropped NSC's case because they claimed India wouldn't cooperate on extradition.

Here is some more evidence guys.. Prashant has been posting on WeddingBee.com a forum for people planning their weddings.. among them, a large amount of jewelry buyers..

He has made a number of postings under different accounts posing as customers who have been ripped off by NSC. There were about a dozen posts, all easily seen as him.

Of course he has always claimed it is not him.. but an actual ex customer, even though the story was full fabricated.

After begging and pleading the forum owners to be more proactive (they had a policy of not deleting postings), I was finally able to get them to remove his posts..

One awesome thing.. All of his posts were made using the TOR proxy.. except one.. where he must have forgotten to use it.. See below.. Hopefully this is good evidence for you guys.
