I hope that this email finds you well.

I am writing to inform you that Michael Arnstein, the President of The Natural Sapphire Company, was recently charged in connection with the use of altered versions of Judge Nathan's 2012 Order, which were submitted to Google. Although the URL addresses submitted to Google contained largely the same content covered by the Order, Mr. Arnstein is alleged to have bypassed the legal process, by altering the orders, rather than submitting them properly.

I hope that you understand that the matter is settled, as between you and the Natural Sapphire Company. The company has no intent to disparage you or your business. Unfortunately, the criminal matter has come to the attention of the press, and we have no control over what they report or how they choose to report it. No one from the Natural Sapphire is reaching out to or speaking to the press.

We have been retained to pursue the removal of re-posted links, which were covered by the Court's original Order. This should not affect you in any way.

Again, the Company regrets that your name was mentioned publicly in connection with Mr. Arnstein's criminal charge.

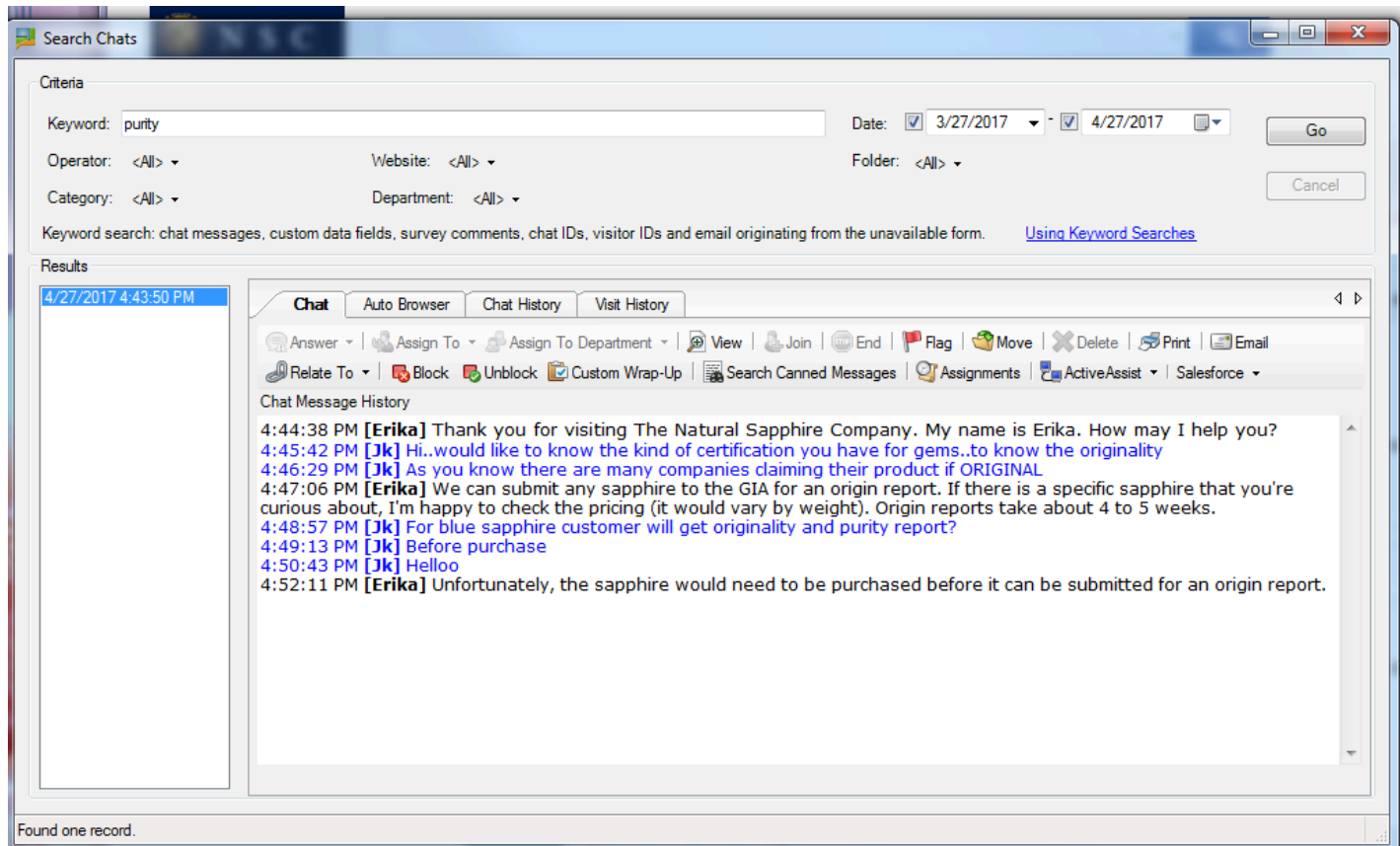

Hello,
