Google Refuses to Comply to Court Order Entirely

We included screen shots and side-by side comparisons of the old and new links to make this clear. We are attorneys hired by The National Sapphire Company and have reviewed all proposed links carefully and compared them with the original Court Order.

Hello,

I am writing to ask that you please reconsider your decision. The reported links consist primarily of links to content that is identical or virtually identical to links that were ordered to be removed by Court Order. We scoured the links, ourselves, to confirm that these are the same content that was covered by the October 26, 2012 Court Order. We provided Google with side-by-side screenshots and links for comparison. There are a smaller number of post-Order defamatory reviews, which also fall within the scope of the Court's Order, which we also reported and identified, as such.

The Court enjoined TPS and its "officers, agents, servants, employees, representatives . . . from directly or indirectly posting negative reviews about NSC," and ordered TPS "to remove all such false reviews, **including but not limited to**, the reviews listed below." It appears that the links listed in the Court Order have been changed in an effort to circumvent the Order, and that the defamatory content that was ordered to be removed is again active. Additionally, a number of new defamatory reviews have been posted.

The owners of the Websites in question will not remove these links, when presented with a Court Order. There is no basis under law to compel a Web site publisher to remove defamatory content posted by a user, and users cannot remove posted reviews from Ripoff Report, Scam Informer, Pissed Consumer, Complaints Board and other copycat complaint sites.

Google previously de-indexed the vast majority of the reported content. The reported content — some seventy false and defamatory reviews — is severely harming the business of The Natural Sapphire Company and we understand that it has resulted in a people losing their jobs, and the company nearly going out of business. Moreover, the reported links are covered by a valid Court Order. I am asking that Google consider this request on its individual merits — if that is done, it is clear that these links should be de-indexed.

To the extent that Google's decision was based upon prior alleged conduct by Michael Arnstein, the C.E.O. of The Natural Sapphire Company, the justice system will address the allegations against Mr. Arnstein. Whatever he is alleged to have done does not make the links reported by our firm any less defamatory, or any less covered by a valid Court Order. We are following the proper process and protocol in reporting these links.

We thank you in advance for your reconsideration.
